Membership Renewal is effective every January of each year in the amount of \$350.00 per company.

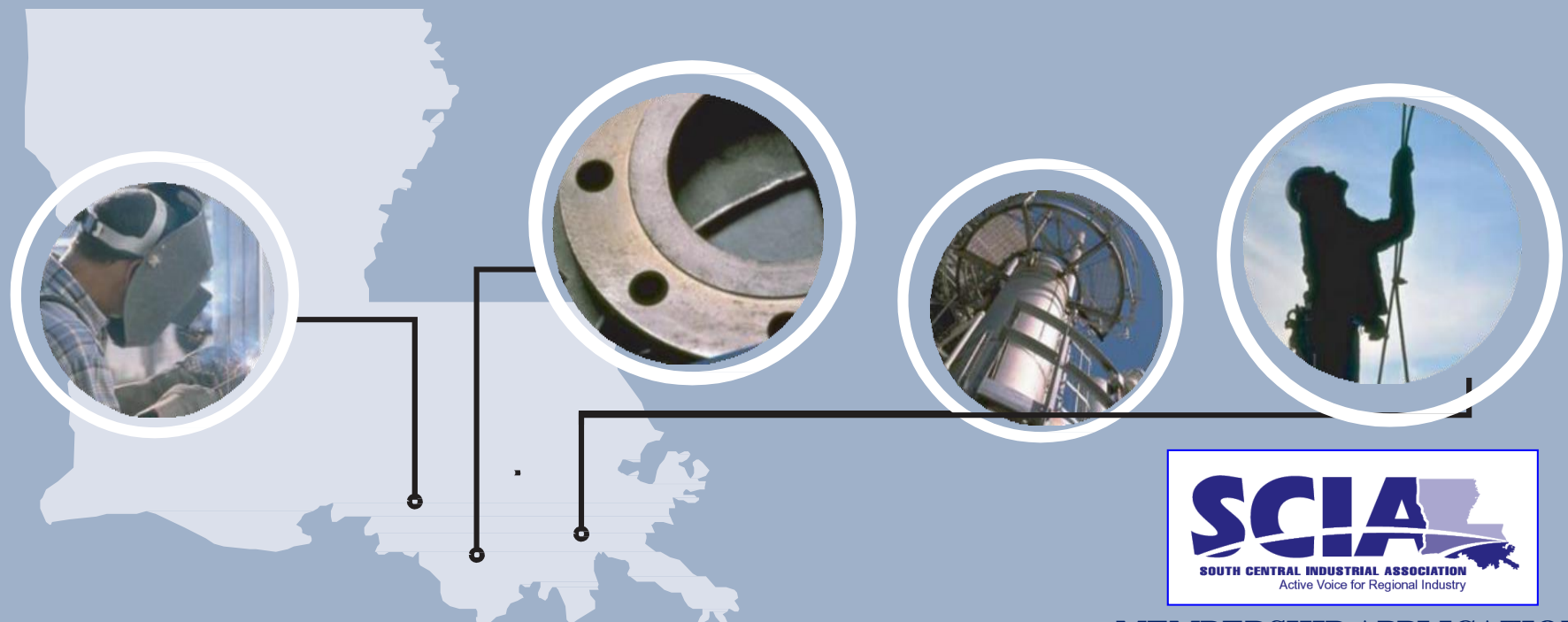

### THE ORGANIZATION

### SCIA GENERAL MEMBERSHIP MEETINGS

The meetings are a great place to network during fellowship time, with about 200 people in attendance each month. ### SCIA MEMBERSHIP DUES

### SCIA ACTIVITIES AND COMMITTEES

The SCIA committees are the cornerstone of the organization, supplying the needed talent to accomplish our goals.

Three of our committees support the organizations' mission through fundraising efforts. The SCIA **Banquet** committee hosts the annual installation of officers and awards event at The Cypress Columns in June of each year. Our annual **Golf Tournament** is led by a team of dedicated golfers. Nothing beats our annual **Crawfish Boil** that is held the Thursday following Easter of each year under the Buquet Pavilion at Southdown Plantation with over 700 people in attendance. These events provide funding for programs such as; Restore Or Retreat, LA 1 Coalition, Morganza Action Coalition, I-49 Coalition, Workforce Development, South Central LA Technical College, Fletcher Technical Community College and Nicholls State University Foundation, as well as several high school scholarships.
